## NOTICE OF REGATTA

### 1 RULES

1.1\* The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.

1.2 The rules of the OCBC PHRF system will apply.

### 2 ADVERTISING

2.1 Competitor advertising will not be restricted.

2.2 Boats may be required to display advertising chosen and supplied by the organizing authority.

### 3\* ELIGIBILITY AND ENTRY

3.1 The regatta is open to all boats at least 25 feet in length.

3.1.1 OCBC boats shall have a valid PHRF on file.

3.1.2 Temporary PHRF numbers will be assigned non-OCBC boats that require one.

3.2 All competitors are encouraged to wear PFD's.

3.4 All competitors under the age of 21 shall wear PFD's.

### 4 FEES

4.1 Required fees are as follows:

Boat Sponsorship           \$500.00

4.2 Other fees:

4.2.1 \$1000 Sponsors shall receive 4 Dinners and a Commemorative Plaque

4.2.2 \$500 Sponsors shall receive 2 Dinners and a Commemorative Plaque.

4.2.3 >\$500 Sponsors may purchase Dinner for \$10.00

4.2.4 Non-sponsors may purchase Dinner for \$25.00

### 5 SCHEDULE

5.1 1800 Competitors Meeting/Best Dressed Crew competition pictures.

5.2 1830 First warning signal.

5.3 Other races will follow ASAP if weather permits.

5.4 No races will be started after 20:00.

5.4 Hors d'oeuvres at the Clubhouse to follow races

5.5 Best Dressed Crew competition voting will be at Lighthouse Dinner June 20, 2015.

## **6 SAILING INSTRUCTIONS**

The sailing instructions will be available at the Competitors Meeting.

## **7 THE COURSES**

The courses sailed will be announced by the Race Committee in accordance with the Sailing Instructions.

## **8 PENALTY SYSTEM**

**8.1** For the all classes rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

**8.3** Decisions of the protest committee will be final as provided in rule 70.5.

## **11 SCORING**

**11.1** The scoring system is Appendix A as modified by the Sailing Instructions.

**11.2** Three races are scheduled.

**11.3** One completed race shall constitute a regatta.

## **12 RADIO COMMUNICATION**

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications **not available to all boats**. This restriction also applies to mobile telephones.

## **13 PRIZES**

Prizes awarded at Lighthouse Dinner June 20, 2015 will be given as follows:

Trophies for 1st, 2<sup>nd</sup>, 3<sup>rd</sup> Place, Most Money.

Hats for Best Dressed Crew

Coasters for all crew.
